## BY-LAW No. 2020-8496

***Being a by-law to amend the City of Timmins By-law No. 2014-7474 establishing rates to be charged for parked vehicles in the City of Timmins***

**WHEREAS** the Municipal Act S.O. 2001, as amended, and the Highway Traffic Act R.S.O. 1990, Chapter H.8, as amended, provides that a Municipal Council may pass By-laws to regulate or prohibit parking; and

**WHEREAS** City of Timmins By-law No. 2014-7474 provides for the regulation of parking and to prohibit parking; and

**WHEREAS** it is considered desirable to amend City of Timmins By-law No. 2014-7474.

**NOW THEREFORE** the Council of The Corporation of the City of Timmins enacts the following as a By-law:

1. THAT Section 8 to City of Timmins Parking By-law No. 2014-7474 to regulate parking and to prohibit parking is hereby amended and replaced with the following:

Monthly parking permits may be obtained from Service Timmins for the fees established in Appendix "A" (Schedule "S" in User Fee By-law) per month for all parking lots described in Schedule "B" to this by-law. Such permits shall be non-refundable. If a hard copy of the permit is issued it shall be displayed in a conspicuous place in the front window of the vehicle to which it has been issued. The number of monthly parking permits issued for each lot shall be subject to a maximum number as may be set out by the City Clerk or his/her Designate

2. THAT Section 9 to City of Timmins Parking by-law 2014-7474 to regulate parking and to prohibit parking is hereby amended and replaced with the following:

Notwithstanding Section 8, monthly parking permits for the Municipal Lot known as the "Knox Lot" shall be issued at the rates established in Appendix "A" (Schedule "S" in User Fee By-law)

3. THAT the attached Set Fine Schedule for By-law No. 2014-7474 be amended as per Appendix "B" attached hereto.
4. THAT this By-law shall come into force and effect when a properly worded signage has been erected indicating the traffic restriction.
